• What is CAIR Coalition?

Capital Area Immigrants' Rights Coalition is the only non-profit organization in the Capital region with a legal services program focused on immigrants who are <u>detained</u>.

In 2019, CAIR Coalition represented 365 clients in their immigration proceedings, including over 80 cases with unaccompanied or separated children.

• What is the impact of #20for20?

Right now, team #20for20 has 125 members. Together, these team members contribute just over \$2,500 each month. Already, that is enough to:







Represent 2 adults in their bond hearings, so they can leave detention, or

Provide grocery support to 50 families, or

Represent one child in prolonged detention, so they can reunite with an adult.

Why #20for20?: The Facts & Figures

How many people are detained in the DC area?

- On average, there are roughly 2,000 immigrant children & adults detained by the immigration system in 10 detention centers in the DC area. (Due to the Remain in Mexico policy and COVID-19, that number is more like 1,000 right now.)
- Only 14% of detained immigrants have access to legal counsel in their removal proceedings.



- Detained immigrants are 11 times as likely to pursue relief when represented by legal counsel, as opposed to accepting a deportation unknowingly or due to hopelessness.
- In 2019, CAIR Coalition represented 365 clients in immigration court, including 80 separated or unaccompanied children.

What's happening due to COVID-19?

- In packed dorms & cells, there is no capacity for social distancing.
- Clients report they have symptoms such as fevers of 105 degrees, coughing, and loss of taste and are not receiving adequate medical care.
- In Farmville Detention Center in Virginia, roughly 90% of all the people detained there tested positive for COVID-19.
- The government is still not accepting humanitarian release requests, so the only way to get released from detention is to win bond in court.



• Since March, CAIR Coalition has represented 44 people in bond hearings. 33 of those 44 people are now out of detention, safely sheltering in place at home!
